Gengler-Johnson House 2024 Avenue K Lot 13, Block 140 Built 1886

The 1906 insurance record for this side-hall, three-bay southern townhouse with double galleries notes a two-story frame building with a shingle roof, elevated on 3 ½ foot brick piers. The record notes that the house contained seven rooms, two halls, one bathroom (plus a water closet), one closet and three porches. The value of the building that year was \$2800. In addition to the main house, the lot contained a wood cistern on a foundation, valued at \$70; a one-story frame building on the northeast corner of the lot that served as a water closet, valued at \$45; a one-story frame building on the northwest corner of the lot that served as a stable, valued at \$60; and a one-story wash-house situated midway along the western lot line, valued at \$50. Fencing around the lot was valued at \$75, for a total property value in 1906 of \$3100.

Notes on the insurance record indicate it was wired for electric lights in 1902 and repaired in 1903. Frederick Johnson is noted as the owner on the 1906 record. Johnson purchased the property in 1904 from Peter Matthew Gengler, son of John and Margaret Gengler, the original owners. City tax records note John Gengler as the owner of this parcel of land as early as 1862.

John and Margaret Scheiber Gengler

John Gengler was born in Borlendorf, Germany, on 21 October 1827. He immigrated to Galveston in 1843. In 1851, John and his brother, Peter Gengler, established a retail grocery business selling vegetables and groceries door to door from a horse-drawn cart. During the Civil War, John Gengler went to sea as captain of a two-masted schooner that transported cotton around the Union blockade, through San Luis Pass, and down to Mexico for resale. At the end of the war, John went back to work at Peter Gengler's grocery store, where he stayed until his retirement. He died at his residence, 2020 Avenue K, on 3 January 1897.

On 19 August 1854, John married Margaret Schreiber. Margaret was born in Bavaria, Germany, on 11 October 1826. She died at the Gengler family residence on Avenue K on 14 November 1899. Her funeral was held at St. Joseph's Catholic Church, two blocks west of the Gengler homestead. She was buried next to John in Old Catholic Cemetery on Broadway.

Seven children were born to John and Margaret in Galveston, four of whom survived to adulthood: Annie Susan (Mrs. Henry C. Schaefer), born 1855, died 1938; Susanna Helena (Mrs. Anton Sommer), born 1858, died 1940; Peter Matthew, born 1868, died 1945; and James Charles, born 1870, died 1938.

In 1916, Peter Matthew and James Charles became president and vice president, respectively, of the Peter Gengler Grocery Company. Peter Matthew would maintain control of the Gengler family grocery business until his death in 1945.⁵

Captain Frederick Wilhelm Johnson and wife, Matilda E. Kramer Johnson

Frederick Wilhelm Johnson was born in Copenhagen, Denmark, on 29 October 1862. Shortly after he immigrated to the United States in 1878-1879, he came to Galveston where he engaged in the shipping trade and was appointed branch pilot of Galveston's harbor on 1 September 1891. ⁶

After the death of his first wife, Eugenia Olhausen in 1897, Captain Johnson married Matilda Kramer on 17 December 1898 in Galveston. Matilda was born on 4 July 1872 in Quintana, Brazoria County, Texas to German immigrant parents Charles Kramer (1836-1902) and Caroline "Lena" Minna (1944-1916). In addition to the five children he shared with Eugenia, two more daughters were born to his union with Matilda; Wilhelmine, born in 1905, and Juliette, born in 1907.

Johnson died at 2024 Avenue K on 1 November 1927. He was buried at Lakeview Cemetery in Galveston. Matilda maintained the residence until her death there in 1944, after which Wilhelmina and Juliette inherited the property. Juliette sold her interest to Wilhelmina in 1945, leaving her sole owner. Wilhelmina, and her husband, resided in the house for a short period of time before they relocated to Sherman Boulevard. After they moved, they maintained ownership of 2024 Avenue K and used it as rental property until they sold it to Jose and Jimmie Candia in 1961.

Jose and Jimmie Candia

Jose Candia was born in Luling, Texas, on 19 November 1911. He moved to Galveston in 1958 where he owned and operated the Galveston Cleaners & Laundry. Jimmie Avis Rodgers Blaylock Candia was born 16 December 1920 in Mississippi. She moved to Galveston sometime during the

1950s and worked in the health care industry until her retirement. Their union was a second marriage for both. After Jose's death in 1978, Jimmie maintained ownership of 2024 Avenue K until her death in 2011. They are buried together at Galveston Memorial Park in Hitchcock, Texas.




1871Bird's Eye View Map, north side, block 140




1885 Sanborn Insurance Map-coincides with the 1885 Bird's Eye View map and shows the footprint of a one-story frame dwelling on lot 13, block 140 and a one-and-one-half story on lot 12. A one-story servants room noted as 219 ½ is located at the rear of the property, occupying ground from both lots. These buildings were destroyed by the 1885 fire. The 1880 U.S. Census recorded John Gengler and family residing in 210 Avenue K, which would have been the house on lot 13.




1889 Sanborn Insurance Map. 2024 Avenue K can be seen for the first time, noted on lot 13. A new one-story building occupies lot 12 (2020 K). John Gengler built both houses after the 1885 fire. He resided in one, and used the other for rental property. It is possible that Gengler and family resided at 2024 Avenue K for a short period of time, but by 1891, the city directories noted John and Margaret residing at 2020 Avenue K, on lot 12 and presumably leasing 2024 K to tenants or extended family.
