1.00 ACRE TRACT

Field Notes Description

Being out of the Ignacio Almansur League, Abstract 120, Fayette County, Texas, also being out of a 1.63 acre tract conveyed from Henry Seydler, Fred Seydler, and Will Seydler to Calvin E. Seydler, by Deed dated May 12, 1958 and recorded in Volume 304, Page 219 of the Official Records of Fayette County, Texas.

Being more fully described by metes and bounds as follows:

BEGINNING: at a 3/8" iron rod, (Y = 13,802,898:06, X = 2,632,425.14), found in the south right of way line of North Street, at the northeast corner of a 4.39 acre tract conveyed to Zaki Ghanem in Volume 1926, Page 815 of the Official Records of Fayette County, Texas, and the northwest corner of said 1.63 acre tract, for the northwest corner of this herein described tract;

THENCE: N 87°49'23" E - 139.70 feet along the south right of way line of said North Street and the north line of this herein described tract, to a 3/8" iron rod found at the northwest of a 1.20 acre tract conveyed to James and Veronica Voigt in Volume 1872, Page 429 of the Official Records of Fayette County, Texas, and the northeast corner of said 1.63 acre tract, for the northeast corner of this herein described tract;

S 01°44′23″ E -311.80 feet along the west line of said 1.20 acre tract and the east line of this herein described tract to a 5/8″ iron rod with cap stamped "RPLS 6368" set at the northeast corner of a 0.63 acre tract (dually surveyed), for the southeast corner of this herein described tract;

THENCE: S 88°02'11" W -139.95 feet across said 1.63 acre tract, along the north line of said 0.63 acre tract, and the south line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set in the east line of said 4.39 acre tract and at the northwest corner of said 0.63 acre tract, for the southwest corner of this herein described tract;

THENCE: N 01°41'41" W - 311.28 feet along the east line of said 4.39 acre tract and the west line of this herein described tract to the *POINT OF BEGINNING*, containing within these metes and bounds a 1.00 acre tract, more or less.
