METES AND BOUNDS DESCRIPTION OF A 11.20 ACRE TRACT OF LAND KNOWN AS TRACT 7 OUT OF AND A PART OF THAT CALLED 119.73 ACRE TRACT OF LAND DESCRIBED IN DEED TO FAROUK ALATTAR AND RIMA ALATTAR RECORDED IN INSTRUMENT NO. 2022099555 OF THE OFFICIAL PUBLIC RECORDS OF FORT BEND COUNTY, TEXAS (O.P.R.F.B.C.,TX) AND SITUATED IN THE H&TC RR CO SURVEY, SECTION NO. 117, ABSTRACT NO. 259 OF FORT BEND COUNTY, TEXAS. SAID 11.20 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at a found mag nail with shiner stamped "Jones/Carter" at the intersection of Beard Road (80 foot right of way) with Kocureck Road (60 foot right of way) marking the most northerly corner of said 119.73 acre tract, the most easterly corner of a called 160 acre tract of land described in deed to Neil O. Yelderman, Pauline Yelderman Anderson, Traci Lynn Yelderman and James D. Yelderman III recorded in Instrument No. 2020009096 O.P.R.F.B.C.,TX, the most southerly corner of a called 640 acre tract of land known as Fourth Tract described in deed to J.D. Yelderman III recorded in Volume 414, Page 502 of the Deed Records of Fort Bend County, Texas (D.R.F.B.C.,TX) and the most westerly corner of a called residue of a 160 acre tract of land described in deed to Dorothy Beard Massey recorded in Volume 309, Page 591 D.R.F.B.C.,TX;

Thence with the northeast line of said 119.73 acre tract, the southwest line of said residue of a 160 acre tract and a line within Kocureck Road South 48 degrees 03 minutes 12 seconds East 1,223.78 feet to a point marking the most easterly corner of the herein described tract and the most northerly corner of a called 15.16 acre tract known as Tract 8 this day surveyed from which a set 5/8 inch iron rod with cap stamped "RPLS 6229" bears South 42 degrees 08 minutes 12 seconds West 30.00 feet and a found 1/2 inch iron rod marking the most easterly corner of said 119.73 acre tract bears South 48 degrees 03 minutes 12 seconds East 750.00 feet;

Thence on, over and across said 119.73 acre tract and with the northwest line of said Tract 8 **South 42** degrees 08 minutes 12 seconds West at 30.00 feet passing said set 5/8 inch iron rod with cap stamped "RPLS 6229" and continuing in all a **total distance of 401.14 feet** to a set 5/8 inch iron rod with cap stamped "RPLS 6229" marking the most southerly corner of the herein described tract and the most easterly corner of a called 10.50 acre tract of land known as Tract 6 this day surveyed;

Thence continuing on, over and across said 119.73 acre tract and with the northeast line of said Tract 6 North 47 degrees 48 minutes 35 seconds West at 1,184.15 feet passing a set 5/8 inch iron rod with cap stamped "RPLS 6229" and continuing in all a total distance of 1,224.15 feet to a point in the northwest line of said 119.73 acre tract, in the southeast line of said 160 acre tract and a point within Beard Road marking the most westerly corner of the herein described tract and the most northerly corner of said Tract 6 from which a found mag nail with shiner stamped "Jones/Carter" marking the most westerly corner of said 119.73 acre tract bears South 42 degrees 11 minutes 25 seconds West 2,240.16 feet;

Thence with the northwest line of said 119.73 and the southeast line of said 160 acre tract North 42 degrees 11 minutes 25 seconds East 395.94 feet to the POINT OF BEGINNING of the herein described tract and containing 11.20 acres within these metes and bounds.
