The aggregate initial principal amounts of all bonds issued are: (i) \$46,500,000 for water, sewer, and drainage facilities; and (iii) \$4,040,000 for road facilities.

The District is located in whole or in part in the extraterritorial jurisdiction of the City of Houston. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a district that is annexed by municipality is dissolved.

The purpose of this District is to provide water, sewer, drainage or flood control, road, and parks and recreational facilities and services. The cost of District facilities is not included in the purchase price of your property.
