THENCE, South 00°34'55" West, along the West line of said Escalante tract, a distance of 99.62 feet to the Southwest corner of said Escalante tract and Point for Corner of the herein described tract;

THENCE, North 02°59'40" West, along the East line of said 4.546 Acre tract, a distance of 94.02 feet to the most Westerly Northwest corner of the herein described tract from which a found 3/4-inch iron pipe bears South 87°51'19" West, 0.4 feet, said corner also being the Southwest corner of a tract of land as deeded to Rosemary Limon Montana, recorded in H.C.C.F. No. Z237140;

THENCE, North 87°51'19" East, along the South line of said Montana tract, a distance of 47.25 feet to the Southeast corner of said Montana Tract and Point for Corner of the herein described tract;

THENCE, North 00°34'55" East, along the West line of said Montana tract, a distance of 99.62 feet to the most Northerly Northwest corner of the herein described tract of land which lies on the South R.O.W. of said West 23rd Street;
