## IN THE CHARLES B. SHAIN SURVEY, ABSTRACT NUMBER 305 BEE COUNTY, TEXAS

BEING an 8.058 acre tract of land situated in the Charles B. Shain Survey, Abstract Number 305, Bee County, Texas, being a portion of that certain called 71.116 acre tract described in instrument to Ryan Pope, recorded under Instrument Number 2747 of the Official Public Records of Bee County, Texas (O.P.R.B.C.T.), said 8.058 acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a $1 / 2$ inch iron rod with cap stamped "TPS 100834-00" found in the southeasterly line of that certain called 1312.380 acre tract described in instrument to Orsted Onshore Real Estate Holdings, LLC., recorded under Instrument Number 1389, O.P.R.B.C.T., for the common northerly corner of said 71.116 acre tract and that certain called 140.53 acre tract, now or formerly described in instrument to Thomas W. Keller and Mary F. Keller, recorded in Volume 601, Page 353, O.P.R.B.C.T., being the northerly corner of the herein described 8.058 acre tract, from which a 1 inch iron pipe found for reference bears, North $69^{\circ} 19^{\prime} 44^{\prime \prime}$ East, 3531.64 feet, said POINT OF BEGINNING having a Texas State Plane Coordinate value of $\mathbf{N} \mathbf{1 3 , 3 9 4 , 8 3 5 . 4 0}, \mathbf{E} \mathbf{2 , 3 1 0 , 7 2 1 . 7 2}$, South Central Zone (4204), grid measurements;

THENCE South $21^{\circ} 33^{\prime} 24^{\prime \prime}$ East, 350.71 feet, with the common line between said 71.116 acre tract and said 140.53 acre tract, to a $1 / 2$ inch iron rod with cap stamped "TPS 100834-00" set for the easterly corner of the herein described 8.058 acre tract;

THENCE severing, over and across said 71.116 acre tract, the following three (3) courses and distances:

1. South $69^{\circ} 29^{\prime} 19^{\prime \prime}$ West, 690.99 feet, to a $1 / 2$ inch iron rod with cap stamped "TPS $100834-00$ " set for corner;
2. North $21^{\circ} 33^{\prime} 24^{\prime \prime}$ West, 252.62 feet, to a $1 / 2$ inch iron rod with cap stamped "TPS 100834-00" set for corner;
3. South $69^{\circ} 29^{\prime} 19^{\prime \prime}$ West, at a distance of 993.15 feet, pass a $1 / 2$ inch iron rod with cap stamped "TPS 10083400 " set for reference in the northeasterly margin of County Road 124 (CR 124), in all, a total distance of 1033.15 feet, to a calculated point in the southwesterly margin of said Cr 124 , the common line between said 71.116 acre tract and that certain called 275.346 acre tract described in instrument to Orsted Onshore Real Estate Holdings, LLC., recorded under Instrument Number 1199, O.P.R.B.C.T., being a southerly corner of the herein described 8.058 acre tract;

THENCE North $20^{\circ} 48^{\prime} 56^{\prime \prime}$ West, 100.34 feet, with the common line between said 71.116 acre tract and said 275.346 acre tract, to a $1 / 2$ inch iron rod with cap stamped "TPS 100834-00" found for the common westerly corner of said 71.116 acre tract and said 1312.380 acre tract, being the westerly corner of the herein described 8.058 acre tract;

THENCE with the common line between said 71.116 acre tract and 1312.380 acre tract, the following two (2) courses and distances:

1. North $69^{\circ} 20^{\prime} 55^{\prime \prime}$ East, 1701.44 feet, to a fence corner post found for corner;
2. North $86^{\circ} 08^{\prime} 38^{\prime \prime}$ East, 22.39 feet, to the POINT OF BEGINNING and containing a computed area of 8.058 acres of land within this Field Note Description.

This Field Note Description was prepared from a survey performed on the ground on September 21, 2023 by Texas Professional Surveying, LLC., Registered Professional Land Surveyors and is referenced to Survey Drawing Project 33701.

Bearings recited hereon are based on GPS observations and are referenced to the North American Datum (NAD) 1983, Texas State Plane Coordinate System, South Central Zone, (4204), grid measurements.
