BEGINNING at a $5 / 8^{"}$ iron rod found in the northeastern right of way of Spur 10 （unknown R．O．W．）for the west corner of the called 64.87 acres as described in F．B．C．C．F．2012097185，and marking the south corner of the herein described parcel；

THENCE，along the northeastern right of way of Sour 10 and a curve to the right having a radius of 2975.00 feet，an arc length of 217.53 feet，and a chord bearing North $45^{\circ} 14^{\prime} 15^{\prime \prime}$ West，a distance of 217.48 feet to a $1 / 2^{"}$ iron rod set with plastic cap for the south corner of the called 5.499 acres as described in F．B．C．C．F． 2006071885，and marking the west corner of the herein described parcel；

THENCE，North $46^{\circ} 58^{\prime} 21^{\prime \prime}$ East（called North $46^{\circ} 58^{\prime} 32^{\prime \prime}$ East），along the southeastern line of the called 5.499 acres，passing at a distance of 1488.18 feet a $5 / 8^{\prime \prime}$ iron rod found for reference，and continuing for a total distance of 1517.37 feet to a point for corner in the centerline of Coon Creek for the east corner of the called 5.499 acres，and marking the north corner of the herein described parcel；

THENCE，South $47^{\circ} 49^{\prime} 17^{\prime \prime}$ East（called South $47^{\circ} 47^{\prime} 59^{\prime \prime}$ East）along the centerline of Coon Creek，a distance of 98.96 feet to a point for corner for the north corner of the called 64.87 acres，and marking the east corner of the herein described parcel；

THENCE，South $42^{\circ} 29^{\prime} 57^{\prime \prime}$ West（called South $42^{\circ} 32^{\prime} 28^{\prime \prime}$ West），along the northwestern line of the called 64.87 acres，passing at a distance of 28.39 feet a $5 / 8^{\prime \prime}$ iron rod found for reference，and continuing for a total distance of 1521.89 feet back to the POINT OF BEGINNING and containing 5.52 acres of land．
