



THENCE SOUTH 02 DEGREES 43 MINUTES 47 SECONDS EAST, CONTINUING ALONG THE WEST RIGHT OF WAY LINE OF SAID STATE HIGHWAY 99 AND THE WEST LINE OF SAID STATE OF TEXAS CALLED 10.783 ACRE TRACT, A DISTANCE OF 537.16 FEET TO THE POINT OF BEGINNING, AND CONTAINING 4.4043 ACRES OF LAND, MORE OR LESS.
