**Previous flooding due to a natural flood event** – 12-28-22--a freak storm caused horizontal rain to enter chimney, run down, & seep under the hardwood floors o first floor. The wood floors were destroyed, replaced with porcelain flooring, all covered under my homeowner/s insurance. These were very unusual circumstances. This answer also pertains to the next question.
