Upon Recording of this Amendment, the Prior Working Capital Assessment shall be amended, restated and replaced in its entirety by the terms and provisions of this Amendment.
- **2.** <u>Subject to Change</u>. The amount of the Working Capital Assessment designated hereunder is subject to change from time to time by Declarant, until the expiration or termination of the Development Period, and the Board thereafter.
- 3. <u>Capitalized Terms</u>. Capitalized terms used by not defined herein shall have the meanings ascribed to such terms in the Covenant.
