THENCE EAST, ALONG THE NORTH LINE OF SAID COLQUIT, PASSING AT 51.43 FEET (CALLED: 50') A ⅓ INCH IRON PIPE FOUND MARKING THE COMMON SOUTH CORNER OF THAT CALLED 1250 SQUARE FOOT TRACT OUT OF SAID LOT 6 AS CONVEYED TO SCHULTZ BY DEED RECORDED IN HCCF № 20070136680 AND THAT TRACT CONVEYED TO ROPER BY DEED RECORDED IN HCCF № 282531 (KNOWN AS "THE EAST ½ OF LOTS 6 & 7 AND THE ADJOINING 50'x20' OF LOT 8), CONTINUING ALONG THE NORTH LINE OF SAID COLQUIT, PASSING AT 104.70 FEET (CALLED: 100') THE COMMON SOUTH CORNER OF SAID ROPER TRACT AND THAT TRACT OF LAND AS CONVEYED TO JONES BY DEED RECORDED IN HCCF № R728291 (KNOWN AS "LOT 12") FROM WHICH A ½ INCH IRON PIPE FOUND BEARS SOUTH, 1.47 FEET, CONTINUING ALONG THE NORTH LINE OF SAID COLQUIT, A TOTAL DISTANCE OF 155.07 FEET (CALLED: 150') TO A 5/8 INCH IRON ROD FOUND MARKING THE COMMON SOUTH CORNER OF LOTS 12 AND 5 OF SAID BLOCK 4, SAME BEING THE SOUTHWEST CORNER AND POINT OF BEGINNING OF THE HEREIN DESCRIBED TRACT OF LAND:

THENCE NORTH, ALONG THE EAST LINE OF "LOT 12", A DISTANCE OF 120.00' TO A ½ INCH IRON ROD SET MARKING THE NORTHWEST CORNER OF THE HEREIN DESCRIBED TRACT OF LAND, SAME BEING THE NORTHEAST CORNER OF SAID "LOT 12" AND THE SOUTHWEST CORNER OF THAT TRACT OF LAND AS CONVEYED TO PAUL MORGAN ASSOCIATES BY DEED RECORDED IN HCCF No Y827628 (KNOWN AS "THE WEST 50' OF LOTS 1 & 2 AND THE ADJOINING 30'x50' OF LOT 3):

THENCE EAST, ALONG THE SOUTH LINE OF SAID MORGAN TRACT, A DISTANCE OF 50.92 FEET (CALLED: 50"), TO A CAPPED 5/8 INCH IRON ROD FOUND MARKING THE NORTHEAST CORNER OF THE HEREIN DESCRIBED TRACT OF LAND, SAME BEING THE SOUTHEAST CORNER OF SAID MORGAN TRACT AND THE SOUTHWEST CORNER OF THAT TRACT OF LAND AS CONVEYED TO BOYAKI BY DEED RECORDED IN HCCF No 20070062376 (KNOWN AS "THE EAST 50" OF LOTS 1 & 2 AND THE ADJOINING 30"x50" OF LOT 3);

THENCE SOUTH, PASSING AT 2.00 FEET THE NORTHWEST CORNER OF THAT TRACT OF LAND AS CONVEYED TO TRIPPER BY DEED RECORDED IN HCCF No S225996 (KNOWN AS "THE EAST ½ OF LOTS 4 & 5 AND THE ADJOINING 18'x50" OF LOT 3), CONTINUING ALONG THE WEST LINE OF SAID TRIPPER TRACT, A TOTAL DISTANCE OF 120.00 FEET TO A ½ INCH IRON ROD SET IN THE NORTH RIGHT-OF-WAY LINE OF THE AFORESAID COLQUIT AND MARKING THE SOUTHEAST CORNER OF THE HEREIN DESCRIBED TRACT OF LAND, SAME BEING THE SOUTHWEST CORNER OF SAID TRIPPER TRACT; A 5/8 INCH IRON ROD FOUND MARKING THE NORTHWEST CORNER OF THE INTERSECTION OF SAID COLQUIT AND GARROT (60" RIGHT-OF-WAY) BEARS EAST 222.00 FEET (CALLED: 227" PER PLAT, 222" PER HARRIS COUNTY APPRAISAL DISTRICT) FROM THIS POINT;

THENCE WEST, ALONG THE NORTH LINE OF SAID COLQUIT, A DISTANCE OF 50.92 FEET (CALLED: 50') TO THE POINT OF BEGINNING AND CONTAINING 6110 SQUARE FEET OR 0.1403 ACRE OF LAND, MORE OR LESS.

1" IRON PIPES WERE FOUND MARKING THE FOUR CORNERS OF THE INTERSECTION OF WEST MAIN (60' RIGHT-OF-WAY) AND THE AFORESAID GARROT AND MARKING THE NORTHEAST CORNER OF THE INTERSECTION OF SAID GARROT AND THE AFORESAID COLQUIT;

A CAPPED ½ INCH IRON ROD FOUND WAS FOUND 50.00 FEET EAST OF THE SOUTHEAST CORNER OF THE INTERSECTION OF SAID COLQUIT AND THE AFORESAID JACK;

A 5/8 INCH IRON ROD FOUND WAS FOUND 64.00 FEET WEST OF THE SOUTHWEST CORNER OF THE INTERSECTION OF SAID WEST MAIN AND GARROT.
