4. To the best of our actual knowledge and belief, since April 17, 2014 there have been no:

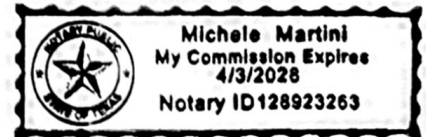
- a. construction projects such as new structures, additional buildings, rooms, garages, swimming pools or other permanent improvements or fixtures;
- b. changes in the location of boundary fences or boundary walls;
- c. construction projects on immediately adjoining property(ies) which encroach on the Property;
- d. conveyances, replattings, easement grants and/or easement dedications (such as a utility line) by any party affecting the Property.

EXCEPT for the following (If None, Insert "None" Below): installation of (1) swimming pool/hot tub at northwest side of property, (2) pool equipment on north (back) side of property, (3) street-facing fence on south side of home, (4) 2 additional AC condensers at north side of property, (5) brick hardscape and gas line for grill at northeast corner of property and (6) additional flatwork installed at SE corner of home. 6. We understand that we have no liability to Title Company that will issue the policy(ies) should the information in this Affidavit be incorrect other than information that we personally know to be incorrect and which we do not disclose to the Title Company.
