## Solar Insure 30 Year Extended Limited Warranty

### for Solar Systems

The limited warranties specified below (hereinafter "Limited Warranty") apply to Solar Systems panels and inverters (hereinafter "Component(s)") and installed by a licensed contractor under applicable local and state laws, and extend only to the original end use purchaser and subsequent owner(s) of the location on which the Component(s) was originally installed (all such persons hereinafter referred to as "Customer"). The warranty start date ("Warranty Start Date") shall be the date the original equipment is installed and commissioned by licensed contractor.

#### Guidelines:

- SolarInsure will, at its sole option, repair or replace the Component(s) if it proves to be defective in material or workmanship for a period ending 30 years from the Warranty Start Date under normal application, installation, use and service conditions. This "30 Year Limited Extended Warranty for Component(s)" does not warrant a specific power output.
- Warranty is transferable between ownership of original installa- tion site only.
- SolarInsure may choose to repair, replace or refund a piece of equipment in its sole discretion.
- Damage to any covered components or consequential damages caused by the use of a non-OEM part will not be covered by this limited warranty.
- 6. If a Component(s) returned to SolarInsure is found not to be defective or this Limited Warranty has expired, the Customer is responsible to pay for return shipping costs.
- 7. The remedies set forth in this Limited Warranty shall be the sole and exclusive remedies, and the original limited warranty period in this Limited Warranty shall not extend beyond the period set forth therein, nor will a new warranty period begin, upon repair or, replacement.

- 1. Unit must be registered and proof of purchase available. 8. Repair or replacement will be made with new or re-manufactured panel(s) or inverters and the replaced panel(s) or parts shall become the property of SolarInsure. In the event the components(s) is no longer available, SolarInsure reserves the right, at its sole option, to deliver new or remanufactured component(s) that may differ in size, color, shape, model number, and/or power level.
  - 9. The Warranty covers both parts and labor necessary to repair the Defective solar Product(s), including labor costs related to uninstalling the Defective Product or re-installing the repaired or replacement product. The Warranty also covers the costs of shipping repaired or replacement product from SolarInsure. The Warranty does not cover, and SolarInsure will not be responsible for, shipping damage or damage caused by mishandling by the freight carrier and any such damage is the responsibility of the freight carrier.
  - Roof Penetration Warranty. Solar Insure provides a roof penetration warranty of thirty (30) years (the "Roof Penetration Warranty Period"), counted from the date the system is installed. During the Roof Penetration Warranty Period, Solar Insure warrants that all roof penetrations made as part of the System installation will be weather-tight (the "Roof Penetration Warranty"). For the avoidance of doubt, this Roof Penetration Warranty does not cover parts already covered by the Manufacturer Warranties. During the Roof Penetration warranty. Solar Insure will at its expense repair or replace any parts or labor covered by the Roof Penetration Warranty.

#### Limited Warranty Exclusion - The Limited Warranty does NOT apply to Component(s):

- Sold and/or installed outside the geographic territory of the United States and US territories;
- Sold AS IS or WITH ALL FAULTS or consumables; or
- That had a serial number or any part thereof altered, defaced or removed.
- This Limited Warranty also does NOT apply to component(s) which have been subjected to:
- Damage and/or failure caused by use on a mobile unit including, but not limited to, vehicles, vessels, etc.;
- 6. Failures due to, accidents, misuse, abuse, neglect, improper installation, improper sizing, or rodent and/or insect infestation
- 7. Damage and/or failure caused by external shock such as flying objects or external stress; or by environmental pollution such as soot, salt damage, or acid rain;
- 8. Damage and/or failure caused by installations not in conformance with the panel(s) specifications, installation manuals, operation manuals, or labels attached to the panel(s);
- 9. Damage and/or failure caused by devices and/or parts other than the panel(s) or by mounting methods of such devices and/or parts;
- 10. Damage and/or failure caused by improper or incorrectly performed maintenance, operation or modification;

- 8. Damage and/or failure caused by removal from the original place of installment;
- Damage and/or failure caused by repairs not in accordance with manufacturer's instructions or non-authorized technicians;
- 10. Damage and/or failure caused by inappropriate handling during storage, packaging or transportation;
- 11. Damage and/or failure caused by non-compliance with national and local electric codes;
- 12. Failure caused by natural forces (earthquakes, floods, lightning, hurricanes, heavy snow, etc.) and fire, power failures, power surges or other unforeseen circumstances that are beyond control;
- A Damage and/or failure caused by external stains or scratches that do not affect output; or by sound, vibration, rust, scratching, or discolorations that are the result of normal wear and tear, aging or continuous use
- The installation of the System may void your existing roof warranty, if any. You should check with the roofer or builder concerning any impact the System will have on an existing roofwarranty. Solar Insure's 30-year Roof Penetration Warranty is not affected by any existing roof warranty. The Limited Warranty and Roof Penetration Warranty do not apply to (a) labor performed with parts not manufactured or purchased by the initial installer.

Except to the extent prohibited by applicable law, any implied warranty of merchantability or fitness for a particular purpose on the panel(s) is limited in duration of this limited warranty. Under no circumstances shall Solar Insure be liable for any incidental, special or consequential damages including, without limitation, lost goodwill, lost revenues or profits, work stoppage, panel(s) failure, impairment of other goods, costs of removal and reinstallation of the panel(s), loss of use, injury to persons or property arising out or related to the panel(s). Solar Insure's total liability, if any, damages or otherwise, shall not exceed the invoice price paid by the customer for the panel(s) furnished, which is the subject of a claim or dispute. Some states do not allow the exclusion or limitation of incidental or consequential damages, or allow limitations on how long an implied warranty lasts, so the above limitations or exclusions may not apply to you. This limited warranty gives the customer specific legal rights; customers may also have other rights that vary from state to state.
