BEGINNING at an iron rod found for the Northeast corner of the said O'Hara 22.824 acre tract of land, same being the Southeast corner of a 15.5 acre tract of land described in Vol. 1385, Page 383, same lying in the West boundary of an 81.75 acre tract described in Vol. 765, P. 153;

THENCE, along the East boundary of said 22.824 acre tract of land and the West boundary of said 81.75 acre tract, S 01°44'05" E 818.19 feet to an iron rod found for the Southeast corner of said 22.824 acre tract, same being the Northeast corner of a 4.5 acre tract in Vol. 1385, P. 391;

THENCE, along the South boundary of said 22.824 acre tract, the North boundary of said 4.5 acres and the North boundary of a 4 acre tract described in Vol. 1385, P. 373, S 88°02'09" W, passing an iron rod set at 1189.44 feet in the East margin of Ehler – Grasshoff Road, a total distance of 1215.13 feet to a point for the Southwest corner of said 22.824 acre tract;
