Thence with the north line of said 21.57 acre tract and the south right of way line of County Road 226
North 87 degrees $\mathbf{3 9}$ minutes $\mathbf{3 9}$ seconds East 274.36 feet to a set $5 / 8$ inch iron rod with cap stamped "RPLS 6229" marking the northeast corner of the herein described tract and the northwest corner of Tract 4 of Saint John Evergreens Subdivision this day surveyed;

Thence on, over and across said 21.57 acre tract with the west line of said Tract 4 South 02 degrees 20 minutes 21 seconds East at 412.62 feet passing a set $5 / 8$ inch iron rod with cap stamped "RPLS 6229" marking the southwest corner of said Tract 4 and the northwest corner of Tract 5 of Saint John Evergreens Subdivision this day surveyed and continuing in all a total distance of 824.68 feet to a set $5 / 8$ inch iron rod with cap stamped "RPLS 6229" in the south line of said 21.57 acre tract and in the north line of a called 27.53 acre tract of land described in deed to Thomas Patrick Workman and Mary Sylvia Workman recorded in Volume 922, Page 597 of the Official Public Records of Lavaca County, Texas (O.P.R.L.C.,TX) marking the southeast corner of the herein described tract and the southwest corner of said Tract 5;

Thence with the south line of said 21.57 acre tract and the north line of said 27.53 acre tract South 87 degrees 49 minutes 01 seconds West 274.36 feet to a set $5 / 8$ inch iron rod with cap stamped "RPLS 6229" marking the southwest corner of the herein described tract and the southeast corner of said Tract 2 from which a found $1 / 2$ inch iron rod bears marking the southwest corner of said 21.57 acre tract bears South 87 degrees 49 minutes 01 seconds West 550.33 feet;

Thence on, over and across said 21.57 acre tract and with the east line of said Tract 2 North 02 degrees $\mathbf{2 0}$ minutes 21 seconds West 823.93 feet to the POINT OF BEGINNING of the herein described tract and containing 5.192 acres within these metes and bounds.
