There was a pinhole leak in apt 2's kitchen ceiling that slowly caused water damage and an insurance claim. When we took apart the ceiling, we sprayed to kill mold, and used a dehumidifier. Water supply plumbing lines have since been upgraded to use pex, which was done without a permit.
