

592 Florida Park

Being a portion of Lots 38 & 39, of River Plantation, Section 1, an addition to the Montgomery County, Texas, according to the plat thereof recorded in Volume 6, Page 51, of the Plat Records of Montgomery County, Texas, same being a tract of land conveyed to Rosalba Hernandez, an unmarried woman, and Anthony Joseph Wells, an unmarried man, by deed recorded in Document No. 2018034105, Official Public Records of Montgomery County, Texas, and being more particularly described by metes and bounds as follows:

BEGINNING at a 1/2 inch iron rod set with a yellow cap stamped "CBG Surveying" for corner, said corner being the Southwest corner of Lot 39, and being the South corner of a tract of land conveyed to Chris M. Bird and William E. Bird, wife and husband, by deed recorded in Instrument No. 2013107296, Official Public Records of Montgomery County, Texas, and being in the West line of Florida Park (a Public right—of—way), from which a 1/2 inch iron rod found for witness bears North 83 degrees 02 minutes 39 seconds East, a distance of 79.95 feet;

THENCE South 20 degrees 11 minutes 17 seconds West, along the West line of said Florida Park, a distance of 60.22 feet to a point for corner, said corner being in the North line of Braxton Bragg Lane (a 60 foot right-of-way), from which a 5/8 inch iron rod found for witness bears North 48 degrees 54 minutes 03 seconds West, a distance of 0.62 feet, being the beginning of a non-tangent curve turning to the right, with a radius of 510.00 feet, a delta angle of 08 degrees 25 minutes 32 seconds, a chord bearing of North 65 degrees 29 minutes 11 seconds West, and a chord length of 74.93 feet;

THENCE along said curve to the right, along the North line of said Braxton Bragg Lane, an arc length of 75.00 feet to a 1/2 iron rod set with a yellow cap stamped "CBG Surveying" for corner;

THENCE North 61 degrees 16 minutes 25 seconds West, along the North line of said Braxton Bragg Lane, a distance of 49.30 feet to a 5/8 inch iron rod found for corner, being the beginning of a tangent curve turning to the left, with a radius of 820.00 feet, a delta angle of 01 degree 36 minutes 25 seconds, a chord bearing of North 62 degrees 04 minutes 34 seconds West, and a chord length of 23.00 feet;

THENCE along said curve to the right, along the North line of Braxton Bragg Lane, an arc length of 23.00 feet to a 1/2 iron rod set with a yellow cap stamped "CBG Surveying" for corner, said corner being the Southeast corner of Lot 37 of said addition;

THENCE North 26 degrees 59 minutes 15 seconds East, along the East line of said Lot 37, a distance of 69.93 feet to a 5/8 inch iron rod found for corner, said corner being the Northeast corner of Lot 37, and being the South corner of Lot 36 of said addition, from which a 5/8 inch iron found for witness bears North 62 degrees 59 minutes 35 seconds West, a distance of 150.00 feet to the North corner of said Lot 37:

THENCE North 43 degrees 59 minutes 47 seconds East, along the Southeast line of said Lot 36, a distance of 61.83 feet to a 1/2 inch iron rod set with a yellow cap stamped "CBG Surveying" for corner, said corner being the West corner of said Bird tract;

THENCE South 28 degrees 59 minutes 27 seconds East, along the Southwest line of said Bird tract, a distance of 94.02 feet to a 1/2 inch iron rod set with a yellow cap stamped "CBG Surveying" for corner;

THENCE South 43 degrees 51 minutes 44 seconds East, along the Southwest line of said Bird tract, a distance of 46.57 feet to the POINT OF BEGINNING and containing 13,200 square feet or 0.30 acres of land.
