Being out of the K. Crier Survey, Abstract 38, Fayette County, Texas, also being out of that same called 70.00 acre tract conveyed to the George A. and Angeline Jahn Estate and described in Gift Deed dated June 4, 1986 and recorded in Volume 721, Page 931 of the Deed Records of Fayette County, Texas.

Being more fully described by metes and bounds as follows:

BEGINNING: at a 5/8" iron rod with cap stamped "RPLS 6368", (Y = 13,792,419.63, X = 2,640,636.56), set in the north right of way line of Jahn Lane, in the south line of said 70.00 acre tract, and at the southwest corner of a 5.00 acre tract, (dually surveyed), for the westerly southeast corner of this herein described tract;

THENCE: S 88°34'24" W - 533.51 feet along the north right of way line of said Jahn Lane, the south line of said 70.00 acre tract, and the south line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set at a southeast corner of a 31.19 acre tract conveyed to Carol Ann Kutac in Volume 1472, Page 795 of the Official Records of Fayette County, Texas, and at the southwest corner of said 70.00 acre tract, for the southwest corner of this herein described tract;

THENCE: N 01°46'29" W - 1713.00 feet along an east line of said 31.11 acre tract, the west line of said 70.00 acre tract, and the west line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set at an angle corner of said 31.11 acre tract, and at the northwest corner of said 70.00 acre tract, for the northwest corner of this herein described tract;

THENCE: N 87°54'51" E - 890.64 feet along the south line of said 31.11 acre tract, the north line of said 70.00 acre tract, and the north line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set at the northwest corner of a 35.19 acre tract, (dually surveyed), for the northeast corner of this herein described tract;

THENCE: S 01°52'58" E - 1165.40 feet along the west line of said 35.19 acre tract and the northerly east line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set at the northeast corner of said 5.00 acre tract, for the easterly southeast corner of this herein described tract;

THENCE: S 85°19'03" W - 437.02 feet along the north line of said 5.00 acre tract and the easterly south line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set at the northwest corner of said 5.00 acre tract, for an angle corner of this herein described tract;




