FIELD NOTE DESCRIPTION OF 1.583 ACRES OF LAND OUT OF THE JOSEPH M. EVERETT 480 ACRE SURVEY, ABSTRACT NO. 207, IN GONZALES COUNTY, TEXAS, AND BEING THAT SAME (1.500 ACRE) TRACT OF LAND CONVEYED TO SHIRLEY NAGELMUELLER IN A DEED AS RECORDED IN VOLUME 1312 PAGE 596 OF THE OFFICIAL PUBLIC RECORDS OF GONZALES COUNTY, TEXAS, AND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at a 3/4" iron pipe found in the northeasterly right-of-way line of Alternate U.S. Highway 90, being at the most southeasterly corner of that certain (1.500 acre) tract of land conveyed to Shirley Nagelmueller in a deed as recorded in Volume 1312 Page 596 of the Official Public Records of Gonzales County, Texas, and being at the most southwesterly corner of that certain (1.134 acre) tract of land conveyed to Donald E. Attilio and Julia T. Attilio in a deed as recorded in Volume 1194 Page 287 of the Official Public Records of Gonzales County, Texas, and being for the most southeasterly corner of the tract herein described, and from which another 3/4" iron pipe found bears S 70 deg. 49' 23" E 207.38 feet, and from that pipe a concrete monument found bears S 71 deg. 21' 50" E 142.40 feet,

THENCE, with the northeasterly right-of-way line of Alternate U.S. Highway 90, being the southwesterly line of the Nagelmueller tract, N 70 deg. 44' 41" W 352.32 feet, to a ½" iron rod found at the most southwesterly corner of the Naglemueller tract, and being at the most southeasterly corner of that certain (0.50 acre) tract of land conveyed to James E. Kocian and Laurie A. Kocian in a deed as recorded in Volume 1115 Page 611 of the Official Public Records of Gonzales County, Texas, and being for the most southwesterly corner of this tract, and from which another concrete monument found bears N 71 deg. 26' 18" W 116.57 feet, and from which another concrete monument found bears N 71 deg. 01' 21" W 623.07 feet,

THENCE, leaving the northeasterly right-of-way line of Alternate U.S. Highway 90, and with the common line between the Nagelmueller tract, and the Kocian tract, N 19 deg. 51' 39" E 193.28 feet, to a 3/4" iron pipe found at the most northwesterly corner of the Naglemueller tract, and being at the most northeasterly corner of the Kocian tract, and being in the southwesterly line of that certain (Second Tract 6.30 acre) tract of land conveyed to Gretchen Elise Kaspar and Paul Edward Kaspar in a deed as recorded in Volume 897 Page 339 of the Official Public Records of Gonzales County, Texas, and being for the most northwesterly corner of this tract, and from which a ½" iron rod found bears S 51 deg. 15' 21" W 1.03 feet, and from that iron rod a concrete monument found bears N 78 deg. 37' 53" W 120.35 feet,

THENCE, with the common line between the Nagelmueller tract, and the Kaspar tract, S 78 deg. 22' 31" W 293.34 feet, to a 3/4" iron pipe found at the most northeasterly corner of the Naglemueller tract, and being at the most northwesterly corner of the Attilio tract, and being for the most northeasterly corner of this tract,

THENCE, with the common line between the Nagelmueller tract, and the Attilio tract, S 04 deg. 52' 27" W 239.73 feet, to the PLACE OF BEGINNING, in all containing 1.583 acres of land.
