The District may, subject to voter approval, impose taxes and issue bonds. The District may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax is \$0.184903 on each \$100 of assessed valuation. The District may impose assessments and issue bonds and impose an assessment in payment of such bonds. The total amounts of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters approved by the voters are: \$17,300,000 for water, sewer, drainage, and storm sewer facilities. The aggregate initial principal amounts of all such bonds issued are: \$14,225,000 for water, sewer, drainage, and storm sewer facilities.

The District is located wholly or partly in the extraterritorial jurisdictions of the City of Hitchcock, the City of Galveston, and the City of Texas City. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a district that is annexed by the municipality is dissolved.
