

business, the following amendment majority vote of the members of the B	t to the Bylaws of the Association was duly approved by a Board:

RECITALS:

- 1. The Bylaws of the Association were recorded in the Official Public Records of Real Property of Waller County, Texas on July 3, 2008, under Clerk's File No. 804739.
- 2. The Association has historically had difficulty establishing a quorum at Members' meetings.
- 3. The Association desires to amend the Bylaws of the Association to reduce the quorum requirement for meetings of the Members when a quorum cannot be obtained.
- 4. Pursuant to Article XIII, Section 1 of the Bylaws and the Texas Business Organizations Code Section 22.102(c), the Board has been vested with the authority to amend the Bylaws.

AMENDMENT:

The Board of Directors hereby amends the Bylaws of the Association as follows:

- 1. Article III, Section 4 entitled "Quorum", shall be deleted and replaced with the following provision:
 - Section 4. Quorum. The presence at the meeting of the Members entitled to cast, or of proxies entitle to cast, absentee ballots and electronic ballots (as approved by the Board) entitled to cast, one-fifth (1/5th) of the votes of each class of the Members shall constitute a quorum for any action except as otherwise provided in the Certificate of Formation, the Declaration, or these Bylaws. If; however, such quorum shall not be present or represented at any meeting, the Members entitled to vote

thereat shall have power to adjourn the meeting from time to time, without notice other than announcement at the meeting, until a quorum shall be present or be represented. In such event a meeting is adjourned for failure to attain a quorum, the quorum requirement for the recalled meeting shall be fifty percent (50%) of the number of Members required to constitute a quorum at the last adjourned meeting. The Members have the power to adjourn and recall the meeting as many times as it takes to achieve a quorum by reducing the quorum requirement each time by fifty percent (50%).

If any provision of this Amendment is found to be in conflict with the Bylaws of the Association, this Amendment shall control.

All other provisions of the Bylaws of the Association shall remain in full force and effect.
