



FIELD NOTES

Part of Lot Twelve (12), Block Two (2), KING'S FOREST, SECTION ONE (1), a subdivision in Harris County, Texas, according to the map or plat thereof, recorded in Volume 193, Page 106, of the Map Records of Harris County, Texas, and being more particularly described by notes and bounds as follows:

BEGINNING at a Nail Set at the Northwest Corner of said Lot Twelve (12), said point also being on the arc of a curve;

THENCE 70.86 feet along the arc of a curve to the left having a chord which bears North 46° 44' 18" East, a chord length of 70.83 feet, a radius of 698.29 feet, and a central angle of 05° 46' 51" to a 5/8 Inch Iron Rod Found at the point of tangency;

THENCE North 43° 49' 53" East, a distance of (called 164.00 feet), Found 144.00 feet as per plat to a 5/8 Inch Iron Rod Found for Corner, the Northeast Corner of said Lot Twelve (12);

THENCE South 37° 56' 04" East, a distance of 148.54 foot to a 5/8 Inch Iron Rod Found for Corner, on the East line of said Lot Twelve (12);

THENCE South 22° 39' 23" East, a distance of 107.96 feet to a 5/8 Inch Iron Rod Found for Corner, on the East line of said Lot Twelve (12);

THENCE South 68° 53' 23" West, a distance of 219.66 foot to a 5/8 Inch Iron Rod Found for Corner, on the West line of said Lot Twelve (12);
