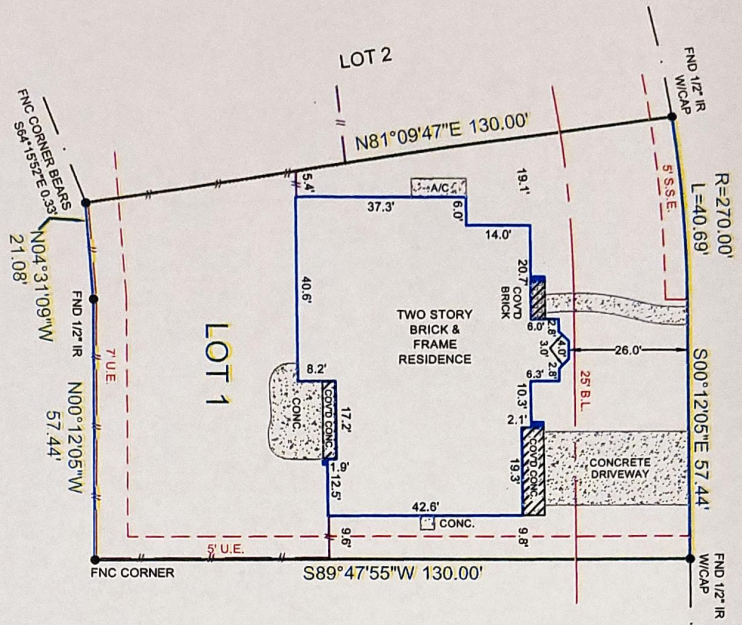


STABLE LAKE DRIVE (PVT.)

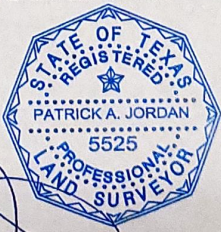
