Pursuant to V.T.C.A., Texas Water Code, Section 49.452, et. seq., as amended, the Board of Directors of the above-named municipal utility district (the "District") now gives the following notice to all sellers and purchasers of real estate situated within the boundaries of said District and requests that you refer to its Notice to Sellers and Purchasers of Real Estate Situated in Fort Bend County Municipal Utility District No. 233, dated August 8, 2019, filed under the Fort Bend County Official Public Records, Clerk's File No. 2019090715:

The only modification and update to the Notice is in regard to Items 3 and 9, which now should read as follows:

- 3. The most recent rate of District taxes on property located in the District is \$0.90 per \$100 assessed valuation.
- 9. The form of the Notice to Purchasers is as follows:

**NOTICE TO PURCHASER OF SPECIAL  
TAXING OR ASSESSMENT DISTRICT**

The real property that you are about to purchase is located in Fort Bend County Municipal Utility District No. 233 (the "District") and may be subject to District taxes or assessments. The District may, subject to voter approval, impose taxes and issue bonds. The District may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax is \$0.90 on each \$100 of assessed valuation. The total amounts of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters and excluding any bonds or any portions of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity, approved by the voters are:

- (i) \$240,000,000 for water, sewer and drainage purposes;
- (ii) \$42,000,000 for road facilities; and
- (iii) \$12,000,000 for parks and recreational facilities.

The aggregate initial principal amounts of all such bonds issued are:

- (i) \$13,615,000 for water, sewer and drainage purposes;

- (ii) \$0.00 for road facilities; and
- (iii) \$0.00 for parks and recreational facilities.



The District is located wholly or partly within the corporate boundaries of the City of Rosenberg. The municipality and the District overlap, but may not provide duplicate services or improvements. Property located in the municipality and the District is subject to taxation by the municipality and the District.

The purpose of this District is to provide water, sewer, drainage, flood control, road, and parks and recreational facilities and services. The cost of District facilities is not included in the purchase price of your property.
