



For the benefits received our annual dues are low.

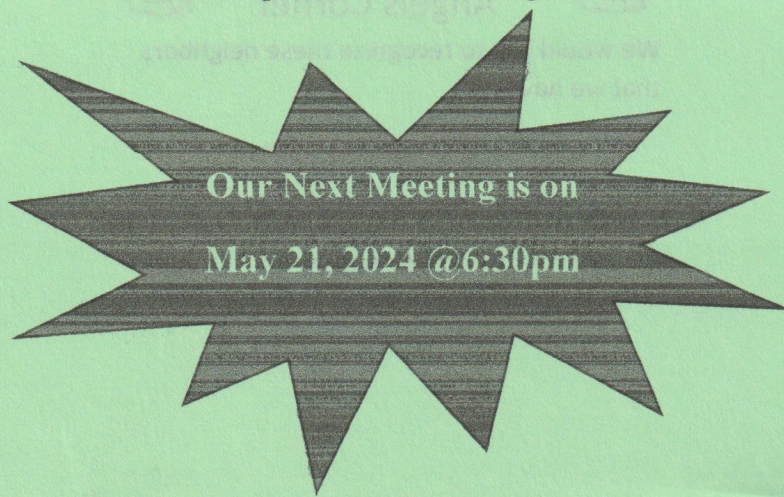
