The outlet for the dishwasher needs to be replaced, sometimes the dishwasher won't run because of the glitchy outlet. The ceiling light in the second bedroom is missing the light cover, but works fine. You can't run too many things on the outside outlets at one time or it will trip the breaker, I would recommend upgrading it if you want to have Christmas lights. Garage is currently enclosed with a wall, however the garage door was left in place and can easily be converted back to a garage by removing the wall.

After a freeze the outdoor spigot pipe cracked in the wall which caused water damage to the wall in the front bedroom. The pipe was repaired and the wall was also repaired. There was a leak that damaged the drywall under the kitchen sink and and joining cabinet. The leak was repaired and dried out but drywall was not replaced.
