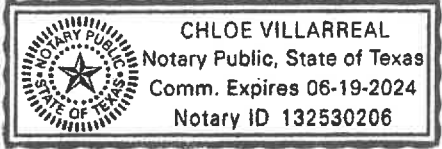
4. To the best of our actual knowledge and belief, since 1/25/2023 there have been no:
