Buyer acknowledges that the square footage of the property and lot have not been measured and confirmed by Seller, its brokers and agents, attorneys, and representatives. Such information is based upon third-party sources and is therefore deemed approximate and not guaranteed. Buyer further acknowledges that Buyer has not relied upon information contained in any such marketing tools and that such tools are not representations or warranties of Seller or any of its brokers, agents, attorneys, or representatives.

Seller has owned the property for a short time and may not be aware if it is in an homeowners association (HOA) community or whether the property is presently subject to HOA assessments, violations, and penalties. AS A MATERIAL PART OF THE CONSIDERATION TO BE RECEIVED BY THE SELLER UNDER THE PURCHASE AGREEMENT FOR THE PROPERTY, AS NEGOTIATED BY THE PARTIES, BUYER HEREBY ACKNOWLEDGES AND HAS AGREED TO ACCEPT THE PROPERTY AT THE TIME OF CLOSING IN ITS "AS-IS, WHERE-IS" CONDITION, WITH ALL FAULTS AND LIMITATIONS, INCLUDING, WITHOUT LIMITATION, ANY DEFECTS OR ENVIRONMENTAL CONDITIONS AFFECTING THE PROPERTY, WHETHER KNOWN OR UNKNOWN, WHETHER SUCH DEFECTS OR CONDITIONS WERE DISCOVERABLE THROUGH INSPECTION OR NOT.
