- Concrete equip pad w/ #3 rebar 4" thick
- Contractor to remove and replace fence back to it's original state
- Contractor to excavate & remove all soil from excavation unless noted
- Finish pool interior with specified plaster choice listed on material selections
- Pool Start up with all chemicals, Pool school training on proper maintenance and use of Hayward Equipment.
- Pool maintenance kit including telescoping pole, wall brush, deep skimmer net and water chemistry test kit.
- Repair grass up to 3 pallets (additional grass needed will be an extra charge)
- Multi-stage job site clean-ups
- All required construction documents supplied for HOA and city permits

- 1. All doors with direct access to the pool area shall be equipped with an alarm which produces an audible warning when the door is opened. The alarm deactivation switch(s)
- shall be located at least 54 inches above the threshold of the door.

  2. No portion of the pool will be allowed in the U.E. This includes the plumbing and electrical.
- 3. The waters edge of the pool cannot be within 5' of any structure unless a signed and stamped original letter from a Certified Engineer is attached.
- 4. All windows within 5 feet of pool must be meet Glazing and wet surfaces requirement listed in 2018 IRC R308.4.5.
- 5.) P-Traps are required for ALL filters. Backflow Preventers for fill lines.
  - 6. Pool heaters need to comply with manufactures specifications.
  - 7. Main drains (pool and Spa) must be installed before steel inspection.
  - 8. All steel must be capped or turned down, for safety.
  - 9. Temporary fencing will need to stay up during construction.
  - 10. No electrical receptacles can be within 6' of waters edge, and at least one is required. All receptacles within 6-20 feet of the pool must be GFCI protected.
  - 11. Access gates shall open outward away from the pool and be self-closing and have a self-latching device.

Where the release mechanism shall be located less than 54 inches from the bottom of the gate, the release mechanism shall be located on the pool side of the gate a minimum of 3 inches below the top of the gate.

Refer to the 2018 International Swimming Pool and Spa Code for Barrier requirements.
