BEGINNING at the Southwest corner of the above mentioned Lot 15B, the Northwest corner of Lot 16 of the Yaupon Subdivision of Lake Mexia recorded as Plat No. 243 of the Plat Records of Limestone County, Texas and being in the East right-of-way of Farm to Market Highway No. 2681, from which a busted concrete right-of-way monument (found) bears South 19 deg. 10 min. 22 sec. West – 395.78 ft., a concrete right-of-way monument (found) bears South 19 deg. 10 min. 22 sec. West – 995.73 ft. and a ½" iron rod (found) at the edge of a rock drive bears North 72 deg. 27 min. 25 sec. West – 0.84 ft.;

THENCE North 19 deg. 10 min. 22 sec. East with the West line of Lot 15B and the East line of Farm to Market Highway No. 2681, a distance of 139.44 ft. to the Northwest corner of same and being the Southwest corner of a called Lot 15A conveyed to Bobby Wayne Sunday in a Transfer of Leasehold Estate in Volume 692, Page 591, from which a ½" iron rod (found) bent bears South 67 deg. 16 min. 38 sec. East – 1.59 ft.;

THENCE South 67 deg. 16 min. 38 sec. East with the North line of Lot 15B, the South line of Lot 15A and with the center of an aerial powerline, a distance of 177.24 ft. to a ½" iron rod (set) for the Northeast corner of Lot 15B and being in the West line of Lake Mexia;

THENCE in a southerly direction with the East lines of Lot 15B and the West contour lines of Lake Mexia as follows:

- 1.) South 10 deg. 03 min. 09 sec. East a distance of 30.79 ft. to a corner,
