 - c. Patterns
 - d. Medical and Student loan collections will be case by case.
- 3. Criminal Background
- 4. Minimum Gross Income Required is 3.5X the Rent Amount.
- 5. Letter of Explanation for Special Circumstance

**Applications need to be emailed in one Scan.

The following is required to run an application; ALL these need to be TOGETHER when we receive the application.

NO INCOMPLETE APPLICATIONS WILL BE PROCESSED.

CHECKLIST:

- 1. Application form One per applicant 18+
- 2. Valid ID or DL
- 3. Acceptable Poof of Income; For example:
 - a. Last 3 check stubs or
 - b. Last 3 bank statements if self-employed; Bank statements need to show deposits accumulated to 3.5X the income per month or add all deposits and divide by 3.5
 - c. SSI Award Letter (if applicable)
 - d. Child support court letter (We only consider court order child support.)
 - e. Notarized letters are NOT acceptable as proof of income.
- 4.Deposit receipt No deposit payment is required until approved. Full deposit is due the same day of approval or next day before 12PM If not, other applications can be reviewed and approved.
- .5. Application fee money order made out to : Thien Hoang
 - a. \$ 95 Per married couple (Common Law Need to have proof or same residency for the past 12 months minimum)
