Warranty 10 years on exterior piers and 5 years on interior piers. Transferable one time only, warranty is not prorated. If said property is sold warranty holders or new owners have 30 days to transfer warranty, or warranty will be voided.

Limited transferable warranty and service agreement, unlimited adjustments to installed piers as needed within the first 3 years after completion, service agreement fees applied thereafter.

Do-Rite Foundation, LLC will not be held accountable for the slab heaving, this occurs due to an increase in moisture or by freezing forces. Heaving is the upward movement of the foundation caused by underlying soils that expand or swell.

Homeowners must maintain property by installing and using soaker hoses in extreme drought, and the homeowner must provide info. of installation and receipt within 30 days of foundation repair. Failure to do so will void warranty. Please refer to the contract for further information on warranty also Do-Rite

Foundation, LLC will not be responsible for plumbing, roofing, flooring, sheetrock and exterior walls. Also for any reason another foundation repair company opens and disturbs any of Do-Rite Foundation, LLC hydraulic driven piers will void warranty automatically.

This warranty applies only to that which is expressly noted herein and does not cover any damage that is the result of abuse, misuse or willful destruction. In the event it is necessary that we need to return to make adjustments or additional repairs. Do-Rite Foundation, LLC requests a few weeks or months advance notice to facilitate scheduling of work. Service fees will apply after three years. This warranty is voided in the event of: any structure changes that are made without prior consultation with company as to effect if homeowner or tenant fails to do proper routine maintenance such as timely plumbing repairs, watering during periods of extreme drought, pest control treatment ect...

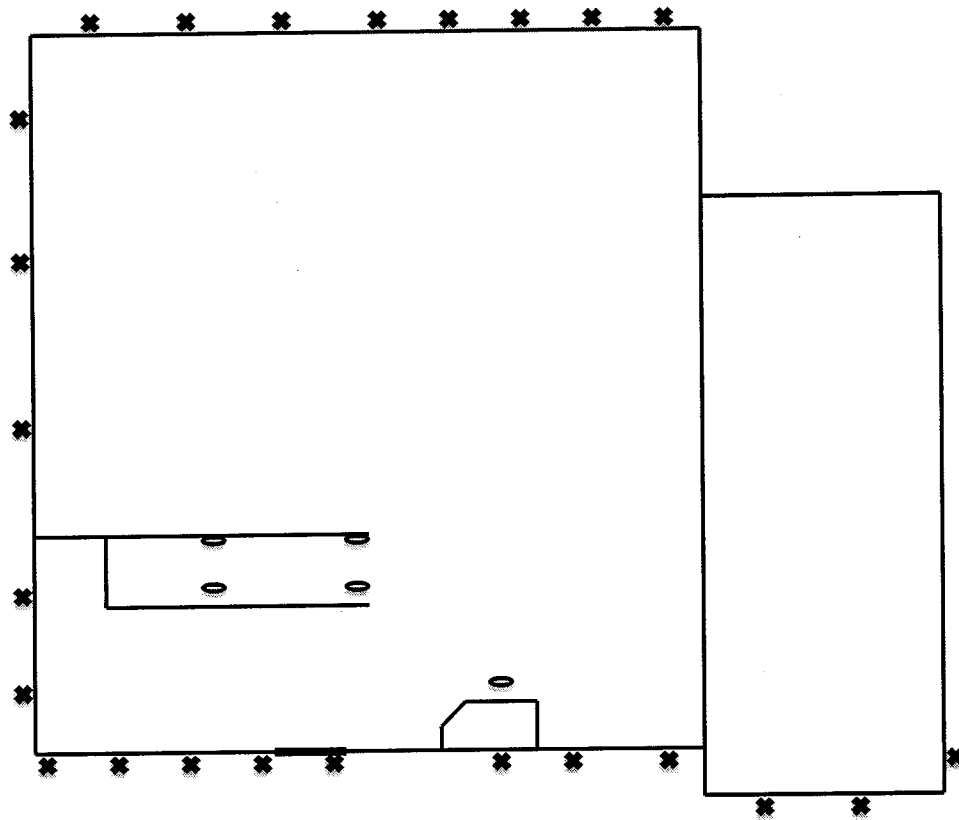
