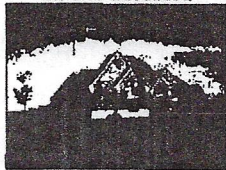
There are no visible conflicts or protrusions, except as shown.

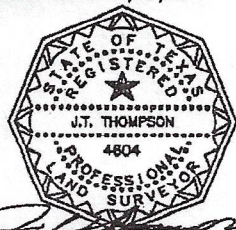
