

NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The real property that you are about to purchase is located in Fort Bend County Municipal Utility District No. 170 (the "District") and may be subject to District taxes or assessments. The District may, subject to voter approval, impose taxes and issue bonds. The District may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax is \$1.04 on each \$100 of assessed valuation.

The total amounts of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters, approved by the voters are:

\$126,140,000 for water, sewer, and drainage facilities;

\$50,400,000 for road facilities; and

\$69,860,000 for parks and recreational facilities.

The aggregate initial principal amounts of all such bonds issued are:

\$30,100,000 for water, sewer, and drainage facilities;

\$0 for road facilities; and

\$6,335,000 for parks and recreational facilities.

In addition to the above bonds, the District is obligated by a contract approved by the voters to pay its pro rata share of the debt service on contract revenue bonds to finance certain regional facilities to serve the District and the other municipal utility districts that are part of the Cross Creek Ranch regional system. The total amount of authorized bonds payable wholly or partly by such contract revenue is \$841,890,000.


The District is located wholly or partly within the corporate boundaries of the City of Fulshear. The municipality and the District overlap, but may not provide duplicate services or improvements. Property located in the municipality and the District is subject to taxation by the municipality and the District.


