**THENCE** North 73°59′23″ West, 18.44 feet, with the transitional intersection of Marsh Drive and South Pine Avenue, to a 5/8 inch iron rod with blue cap inscribed "Tablerock Survey, LLC" set for the southwest corner of the herein described tract;
