METES AND BOUNDS DESCRIPTION OF A 9.075 ACRE TRACT OF LAND BEING ALL OF THAT CALLED 9.084 ACRE TRACT OF LAND DESCRIBED IN DEED TO HIDDEN OAKS TEXAS, LLC RECORDED IN VOLUME 1727, PAGE 447 OF THE OFFICIAL RECORDS OF WASHINGTON COUNTY, TEXAS (O.R.W.C.,TX) AND SITUATED IN THE SAMUEL M WILLIAMS SURVEY, ABSTRACT NO. 109 AND IN THE HORATIO CHRIESMAN SURVEY, ABSTRACT NO. 24 IN WASHINGTON COUNTY, TEXAS. SAID 9.075 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at a found 3/8 inch iron rod in the northeast right of way line of North Highway 36 marking the most westerly corner of said 9.084 acre tract and the most southerly corner of a called 5.17 acre tract of land described in deed to Carlos Antonio Garcia and Yanira Garcia recorded in Volume 1564, Page 484 O.R.W.C.,TX;

Thence with the northwest line of said 9.084 acre tract and the southeast line of said 5.17 acre tract **North 61 degrees 40 minutes 54 seconds East** at 666.54 feet **passing** a found 1/2 inch iron rod with cap stamped "RPLS 5935" marking the most easterly southeast corner of said 5.17 acre tract and the most southerly corner of a called 2.417 acre tract of land described in deed to Maria Del Carmen Gore and Cameron C. Gore recorded in Volume 1558, Page 58 O.R.W.C.,TX and further described in Volume 1558, Page 54 O.R.W.C.,TX and continuing in all a **total distance of 1,032.53 feet** to a found 1/2 inch iron rod in the west right of way line of Affleck Road marking the northeast corner of said 9.084 acre tract and the most easterly corner of said 2.417 acre tract;

Thence with the east line of said 9.084 acre tract and the west right of way line of Affleck Road **South 03 degrees 06 minutes 04 seconds East 685.93 feet** to a found 1/2 inch iron rod in the north line of a called 5.18 acre tract of land described in deed to Connie Rose Gaskamp recorded in Volume 819, Page 76 O.R.W.C.,TX marking the southeast corner of said 9.084 acre tract;

Thence with the south line of said 9.084 acre tract and the north line of said 5.18 acre tract **South 89 degrees 56 minutes 04 seconds West 763.87 feet** to a found 1/2 inch iron rod in the northeast right of way line of North Highway 36 marking the southwest corner of said 9.084 acre tract and the northwest corner of said 5.18 acre tract;

Thence with the southwest line of said 9.084 acre tract and the northeast right of way line of North Highway 36 North 42 degrees 54 minutes 37 seconds West 267.60 feet to the POINT OF BEGINNING of the herein described tract and containing 9.075 acres within these metes and bounds.
