## FIELD NOTE DESCRIPTION 1.107 ACRES IN THE THOMAS G. STEWART SURVEY, ABSTRACT NO. 529 MONTGOMERY COUNTY, TEXAS TRACT 2

BEING a 1.107 acre tract of land situated in the Thomas G. Stewart Survey, Abstract No. 529, Montgomery County, Texas, and being out of and a portion of a called 69.862 acre tract of land as described in deed recorded under County Clerk's File No. 9833650 of the Official Public Records of Real Property of Montgomery County, Texas and being more fully described by metes and bounds as follows with all bearings based on a deed call of S29°16'00"E along a westerly line of said 69.862 acre tract:

COMMENCING at a found concrete monument situated in the apparent and occupied easterly right-of-way line of Dotty Lane, same point being the south west corner of that called 25.5734 acre tract of land described in deed to Ronald D. Magness, recorded under County Clerk's File No. 2005-092362 and being the north westerly corner of the herein described tract of land;

THENCE S89°42'00"E 383.63' and with Magness's south line to a 1/2" iron rod set for the POINT OF BEGINNING.

THENCE S23°49'57"E 224.15' and severing said 69.862 acre tract to a 1/2" iron rod set for an angle point;

THENCE \$15°23'11"W 156.14' and severing said 69.862 acre tract to a 1/2" iron rod set for and an angle point;

THENCE S47°11'19"W 60.24' and severing said 69.862 acre tract to a 1/2" iron rod set in the apparent and occupied easterly right-of-way line of Williams Road for the most south easterly corner of the herein described tract and from which a found 1/2" iron rod bears S29°16'00"E 461.51' for reference;

THENCE N29°16'00"W 37.45' and with the apparent and occupied easterly right-of-way line of Williams Road to a found 1/2" iron rod for an angle point;

THENCE N68°16'29"W 144.20' and with the apparent and occupied northerly right-of-way line of Williams Road to a 1/2" iron rod set for the most south westerly corner of the herein described tract of land;
