BEGINNING at a point in the westerly right-of-way (R.O.W.) line of Live Oak Drive (60' R.O.W.) for the common Southeast corner of herein described Tract and the northeast corner of Lot 27, Block 3, Thousand Oaks, Section 2, from which a found iron rod Bears S61°52'37"E, 0.57';

THENCE S 58°19'42" W, 504.42', departing the westerly R.O.W. line of Live Oak Drive and along the common South line of herein described Tract and the north line of Lots 27, 26 and 25, Block 3, of said Thousand Oaks, Section 2, to a point in the east line of a Lot 19, Block 3, of said Thousand Oaks, Section 2, for the common Southwest corner of herein described Tract and the northwest corner of said Lot 25, Block 3, Thousand Oaks, Section 2, from which a found iron rod Bears S87°39'20"W, 0.49';

THENCE N 51°31'12" W, 120.47', along the common Southwesterly line of herein described Tract and the northeasterly line of Lot 19 and Lot 14, Block 3, of said Thousand Oaks, Section 2, to a found iron rod for an exterior angle point and corner of herein described Tract, same point being the south corner of Lot 20, Block 3, of said Thousand Oaks, Section 1;


THENCE N 00°22'08" W, 151.30', along the common West line of herein described Tract and the east line of said Lot 20, Block 3, of said Thousand Oaks, Section 1, to a found iron rod for the common Northwest corner of herein described Tract, the northwest corner of Lot 29, Block 3, of said Thousand Oaks, Section 1 and the southwest corner of Lot 28, Block 3, of said Thousand Oaks, Section 1;

THENCE N 64°19'30" E, 467.88', crossing Lot 29, Block 3, of said Thousand Oaks, Section 1 and along the common North line of herein described Tract and the south line of a tract conveyed to Stephen C. Muse and Melissa Taylor Muse, recorded in C.C.F. No. 2007-085706, O.P.R.R.P.M.C.T., to a set ½" iron rod with orange plastic cap stamped "Precision Surveyors" (hereinafter called "set ½" iron rod") in the westerly R.O.W. line of said Live Oak Drive, for the common Northeast corner of herein described Tract and the southeast corner of said tract conveyed to Stephen C. Muse and Melissa Taylor Muse;

THENCE S 22°22'47" E, along the common westerly R.O.W. line of said Live Oak Drive and the East line of herein described Tract, at 18.23' pass the original northeast corner of said Lot 29, Block 3, Thousand Oaks, Section 1, in all a total distance of 44.31', to a point at the beginning of a curve to the left and a corner of herein described Tract;

THENCE in a Southeasterly direction continuing along the common westerly R.O.W. line of said Live Oak Drive and the East line of herein described Tract and said curve to the left having a RADIUS of 307.46' DELTA of 18°51'32", LENGTH of 101.20', CHORD BEARING of S31°48'33"E and a CHORD LENGTH of 100.74', to a set ½" iron rod at the end of said curve to the left for a corner of herein described Tract;

THENCE S 41°14′20" E, 49.93', continuing along the common westerly R.O.W. line of said Live Oak Drive and the East line of herein described Tract to the POINT OF BEGINNING containing 2.5689 acre (111,899 square feet) of land.
