Transferring Your Ram Jack Warranty On a Timely Basis: Instructions

Hi. Thank you for calling.

You have contacted us to transfer your Warranty. We have attached the procedure, instructions, and documents that you must complete before any transfer is approved. Before closing on a sale/transfer of your home, you must do the following unless recommended:

- We recommend you transfer at closing when a Notary Public is present, and both parties will sign on or around the same day.
- We recommend the title company hold the transfer documents for signature. Sign, date, and notarize the Warranty Transfer Documents and Applications at closing.
- Give all the documents stated in the attached Warranty Transfer Applications (Present Owner and Buyer) to the new owner, a copy of the Closing Statement's first page showing names of the parties and date, and this Instruction Sheet.
- The new owner is required to send the completed Warranty Transfer Applications Documents and the Warranty Transfer Fee to Ram Jack within 60 days of the transfer to the address above.
- If you and the new owner do not follow all of the above instructions, the transfer is void, and no Warranty will exist on the property.
- After Ram Jack receives and reviews all of the completed documents and approves the application, Ram Jack will issue its current Limited Warranty to the new owner.
- If all documents are not complete when received, Ram Jack will notify you. But Ram Jack must receive all documents by the 60th day after the transfer, or the transfer is void - no exceptions.
- You must complete the transfer on a timely basis. If you do not complete the transfer within 60 days, any transfer is subject to additional fees, inspections, costs. Any approval of an untimely transfer is solely at our professional discretion based upon our inspection and payment of fees.
- We recommend the buyer phone Ram Jack within a week of mailing the documents and fee. They will want to ensure Ram Jack has received all documents before the 60-day transfer period expires.

2. I have completed and enclosed this Application, the Signed and Notarized Warranty Owner Application, transfer fee of <u>\$_500.00___</u>, and a signature and date page of the Closing Statement.

3. I have provided evidence that I sent this Application within 60 days of the closing/transfer date to Ram Jack by way of a mail/delivery receipt that is shown on the envelope or other packaging AND a copy of 1 page (or more) of the closing statement with seller and buyer's names and the closing date appearing on the page.

4. I have no knowledge that any person other than Ram Jack worked on, disturbed, or adjusted the Ram Jack system of foundation support. If Ram Jack approves my warranty transfer, I understand that if any person other than Ram Jack works on, disturbs, or adjusts the Ram Jack system of foundation support, or that anyone other than Ram Jack performs additional foundation support work on my property ("improvement site" or "site"), or if the construction of my structure is altered, that my Limited Warranty is void from the date of any approved warranty transfer.

5. I recognize that I have no rights under any Ram Jack Agreement for Work related to the site, and I hereby release Ram Jack from all liability as to its previous work, the work it did not conduct, and any previous warranty claims. I recognize that I only have legal rights against Ram Jack as to its current Limited Warranty and surrender all other claims.

6. I understand that a Ram Jack pile is designed to resist vertical settlement over a limited area directly above the pile, and that the Warranty only covers the downward movement of each pile and does not cover damages that any movement of a pile causes to the foundation, floor, structure, or any of its components at the site. I recognize that Ram Jack is granting me its current Limited Warranty, which may differ in detail from any previous Limited Warranty, and I accept this Limited Warranty.

7. I also acknowledge that Ram Jack may change the Limited Warranty, at its discretion, but its coverage that any Ram Jack driven or helical pile, which Ram Jack installs at your property, will not move downward for the life of your structure, will remain in effect.

8. I acknowledge that if any statement in this application is false or any transfer documents are not properly executed, as determined in the sole discretion of Ram Jack, that the limited warranty is void as of the date of any approved transfer.
