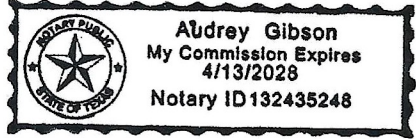
4. To the best of our actual knowledge and belief, since 12/2010 there have been no:
