THENCE North 02°50'27" West, 139.63 feet, with the common line between said Brewton tract and said Lot 94, to a 1/2 inch iron rod with cap stamped "TPS 100834-00" set for the common corner of said Brewton tract, said Lot 94, that certain tract described as the East 1/2 of Lot 87, of said Holiday Oaks, in instrument to Jorge Armando Chavez Lara and Daria Martinez Torres, recorded under Clerk's File Number 2019016029, O.P.R.M.C.T., and Lot 86 of said Holiday Oaks, in instrument to Larry E. Hightower, recorded under Clerk's File Number 2022101796, O.P.R.M.C.T, being the northwesterly corner of the herein described 0.159 acre tract;

THENCE North 87°09'33" East, 49.69 feet, with the common line between said Brewton tract and said Lot 86, to a 1/2 inch iron rod with cap stamped "TPS 100834-00" set for the common northerly corner of said Brewton tract and that certain tract described as the East 50 feet of Lot 95 of said Holiday Oaks, in instrument to Alejandro Rivera Agundiz (Agundiz Tract), recorded under Clerk's File Number 2018099021, O.P.R.M.C.T., being the northeasterly corner of the herein described 0.159 acre tract, from which a 1/2 inch iron rod found for the common corner of said Agundiz tract, said Lot 86, that certain tract described as the West 50 feet of Lot 96 of said Holiday Oaks, in instrument to Mary Amanda Brewton, recorded under Clerk's File Number 2010113110, O.P.R.M.C.T., and that certain tract described as the East 50 feet of Lot 85 of said Holiday Oaks, in instrument to Larry E. THENCE South 02°50'27" East, 139.63 feet, with the common line between said Brewton tract and said Agundiz tract, to a 1/2 inch iron rod with cap stamped "TPS 100834-00" set in the northerly right of way of said Double X, for the common southerly corner of said Brewton tract and said Agundiz tract, being the southeasterly corner of the herein described 0.159 acre tract;

THENCE South 87°09'33" West, 49.69 feet, with the northerly right of way of said Double X, with the southerly line of said Brewton tract, to the **POINT OF BEGINNING** and containing a computed area of 0.159 acres of land within this Field Note Description.
