

NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The real property that you are about to purchase is located in the Fort Bend County Municipal Utility District No. 187 (the "District") and may be subject to District taxes or assessments. The District may, subject to voter approval, impose taxes and issue bonds. The District may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax is \$0.6535 on each \$100 of assessed valuation.

The total amounts of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters and excluding any bonds or any portions of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity], approved by the voters are:

\$137,535,000 for water, sewer, drainage and flood control facilities;
\$20,825,000 for road facilities;
\$29,160,000 for parks and recreational facilities; and
\$680,000 for fire facilities.

The aggregate initial principal amounts of all such bonds issued are:

\$32,030,000 for water, sewer, drainage and flood control facilities;
\$10,300,000 for road facilities;
\$4,005,000 for parks and recreational facilities; and
\$0 for fire facilities.

The District is located wholly or partly in the extraterritorial jurisdiction of the City of Richmond. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a District that is annexed by the municipality is dissolved.

The District has entered into a strategic partnership agreement with the City of Richmond. This agreement may address the timeframe, process, and procedures for the municipal annexation of the area of the District located in the municipality's extraterritorial jurisdiction.

The purpose of the District is to provide water, sewer, drainage, flood control, firefighting, road, parks and recreational facilities and services. The cost of District facilities is not included in the purchase price of your property.

\$45,565,000 for drainage and flood control facilities and refunding;
