The purpose of the District is to provide drainage and flood control facilities and services within the District through the issuance of bonds payable in whole or in part from property taxes or exclusively through the issuance of property taxes. The cost of these utility facilities is not included in the purchase price of your property, and these utility facilities are owned or to be owned by the District or other governmental entities.
