#### Abstract

METES AND BOUNDS DESCRIPTION OF A 1.500 ACRE TRACT OF LAND KNOWN AS TRACT NO. 1 OUT OF AND A PART OF THAT CALLED 9.084 ACRE TRACT OF LAND DESCRIBED IN DEED TO HIDDEN OAKS TEXAS, LLC RECORDED IN VOLUME 1727, PAGE 447 OF THE OFFICIAL RECORDS OF WASHINGTON COUNTY, TEXAS (O.R.W.C. ,TX) AND SITUATED IN THE HORATIO CHRIESMAN SURVEY, ABSTRACT NO. 24 IN WASHINGTON COUNTY, TEXAS. SAID 1.500 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:


BEGINNING at a found $1 / 2$ inch iron rod in the west right of way line of Affleck Road marking the northeast corner of said 9.084 acre tract and the southeast corner of a called 2.417 acre tract of land described in deed to Maria Del Carmen Gore and Cameron C. Gore recorded in Volume 1558, Page 58 O.R.W.C., TX and further described in Volume 1558, Page 54 O.R.W.C.,TX;

Thence with the east line of said 9.084 acre tract and the west right of way line of Affleck Road South 03 degrees 06 minutes 04 seconds East 330.81 feet to a set 5/8 inch iron rod with cap stamped "RPLS 6229" marking the southeast corner of the herein described tract and the northeast corner of a called 1.500 acre tract of land known as Tract No. 2 this day surveyed from which a found $1 / 2$ inch iron rod marking the southeast corner of said 9.084 acre tract bears South 03 degrees 06 minutes 04 seconds East 355.11 feet;

Thence on, over and across said 9.084 acre tract with the north line of said Tract No. 2 this day surveyed South 86 degrees 53 minutes 56 seconds West 240.28 feet to a set $5 / 8$ inch iron rod with cap stamped "RPLS 6229" marking the southwest corner of the herein described tract and the northwest corner of said Tract No. 2;

Thence continuing on, over and across said 9.084 acre tract North 01 degrees 46 minutes $\mathbf{3 7}$ seconds West 220.11 feet to a set $5 / 8$ inch iron rod with cap stamped "RPLS 6229" in the north line of said 9.084 acre tract and the south line of said 2.417 acre tract marking the northwest corner of the herein described tract from which a found $3 / 8$ inch iron rod marking the most westerly corner of said 9.084 acre tract bears South 61 degrees 40 minutes 54 seconds West 772.56 feet;

Thence with the north line of said 9.084 acre tract and the south line of said 2.417 acre tract North 61 degrees 40 minutes 54 seconds East 259.97 feet to the POINT OF BEGINNING of the herein described tract and containing 1.500 acres within these metes and bounds.
