RESTRICTIONS FLOWING WELLS SUBDIVISION

- 1. There shall not be built on said property any permanent residence with less than 500 square feet. The outside wells of every residence shall be covered immediately upon completion with two coats of good paint. A log house may be erected only when approved by the Seller. Temporary dwellings must be built not •nearer than 50 feet to the front line of any lot. All temporary buildings used as a residence must be vacated within 120 days from date of construction.
- 2. No part of any building shall be erected nearer to the front line of the lot than 30 feet.
- 3. No cess pool shall ever be dug, used or maintained on such tract and whenever a residence is established on said tract, all toilets shall be connected with a septic tank until such time as sanitary sewers may be available for use in connection with such tract. The drainage of septic tanks in road, street or alley, or other public ditches, lakes or river, either directly or indirectly, is strictly prohibited.
- 4. Drainage, structures under private driveways shall have a net drainage opening area of sufficient size to permit the free flow of water without backwater. This condition shall apply to walks and driveways alike.
