\$14,400,000 for road facilities; and

\$7,355,000 for parks and recreational facilities.

The aggregate initial principal amounts of all such bonds issued are:

\$31,895,000 for water, sewer, and drainage facilities;

\$11,500,000 for road facilities; and

\$0.00 for parks and recreational facilities.

The district is located wholly or partly in the extraterritorial jurisdiction of the City of Rosenberg. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a district that is annexed by the municipality is dissolved. The district is located wholly or partly within the corporate boundaries of the City of Rosenberg. The municipality and the district overlap, but may not provide duplicate services or improvements. Property located in the municipality and the district is subject to taxation by the municipality and the district.

The purpose of the district is to provide water, sewer, drainage, flood control, fire-fighting, road, parks and recreational, or other types of facilities and services. The cost of district facilities is not included in the purchase price of your property.
