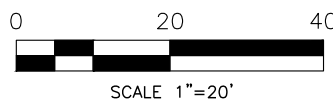


**NOTES**

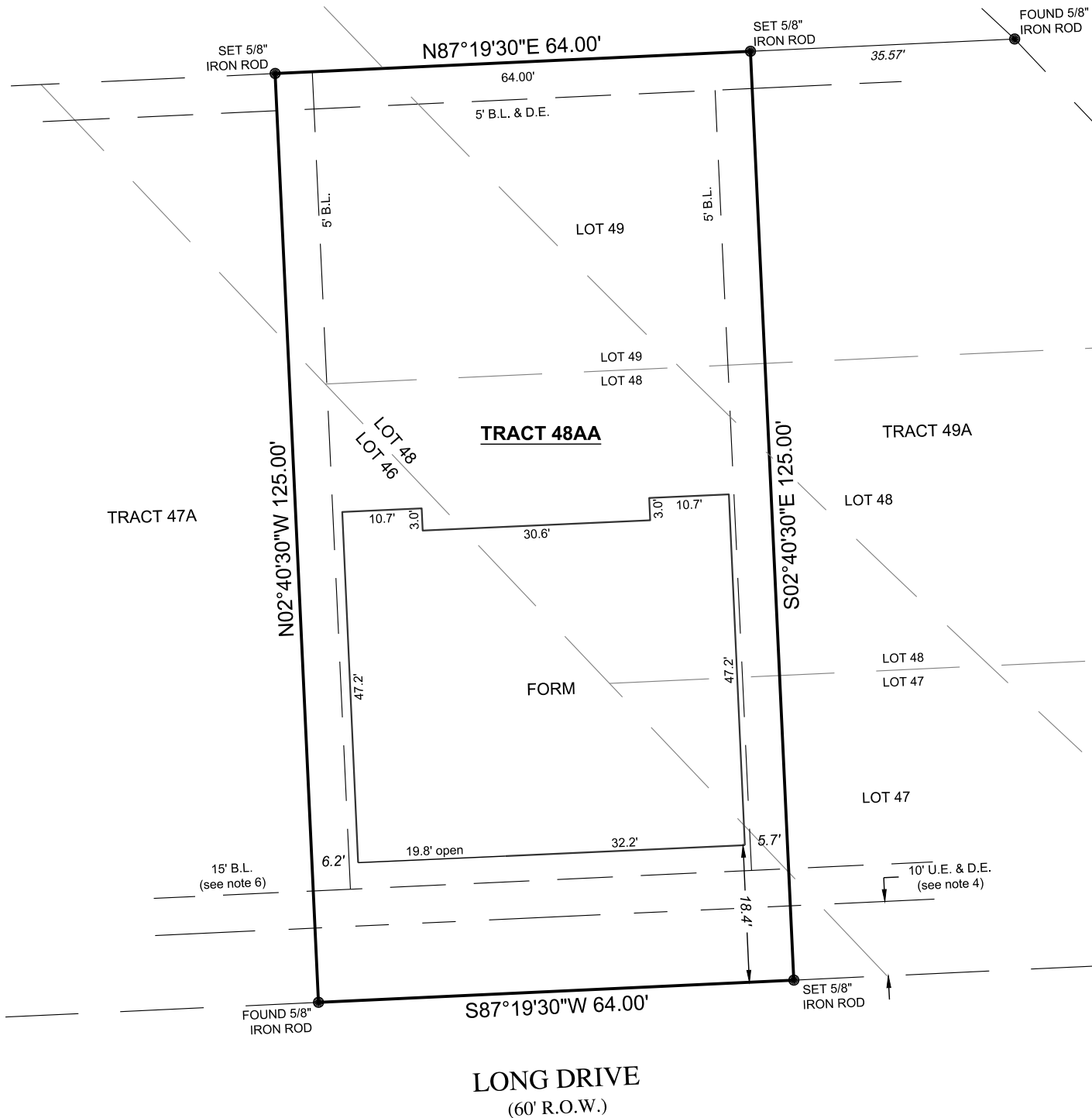
