- (iii) \$1,100,000 for parks and recreational facilities.

- (i) \$7,020,000 for water, sewer, and drainage facilities;
- (ii) \$-0- for road facilities; and
- (iii) \$1,100,000 for parks and recreational facilities.

The purpose of this District is to provide water, sewer, drainage or flood control facilities and services and roads within the District through the issuance of bonds payable in whole or in part from property taxes. The cost of these utility facilities is not included in the purchase price of your property, and these utility facilities are owned or to be owned by the District.
