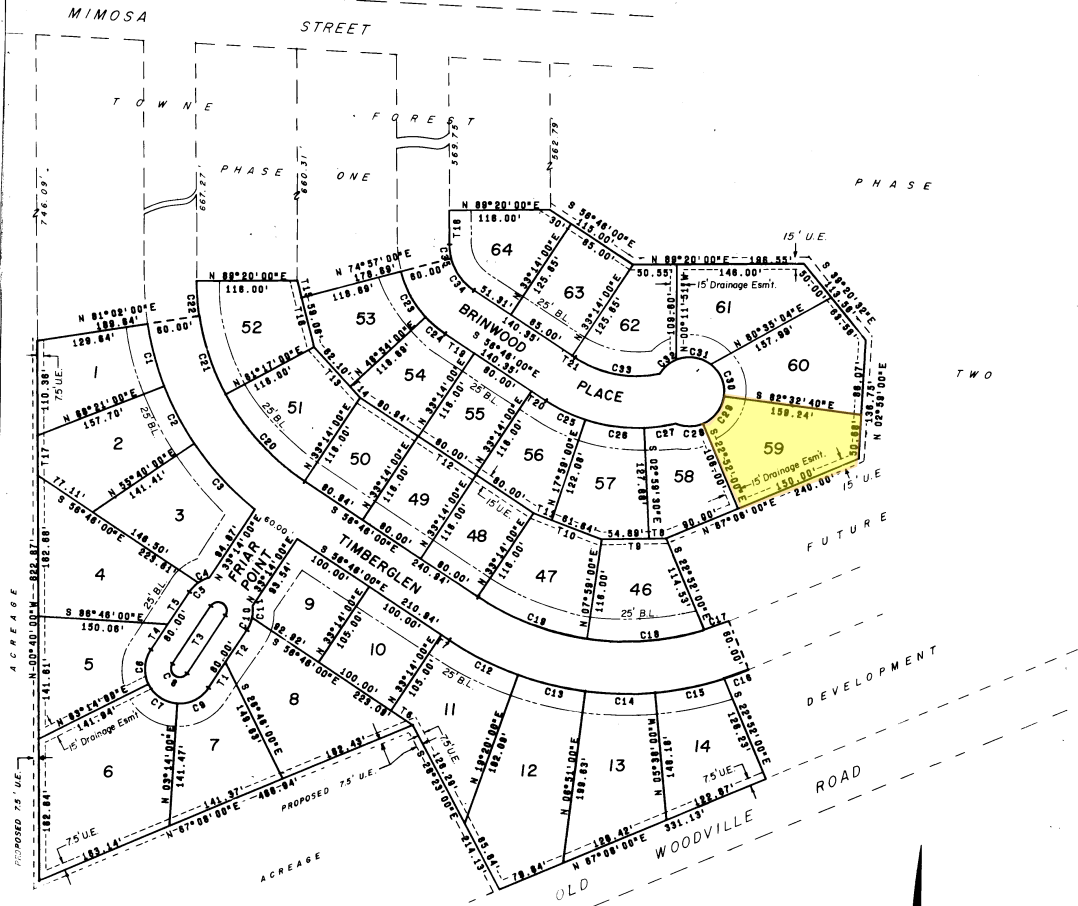


DISTANCE TO HOUSTON AVE. = 1,368.67'

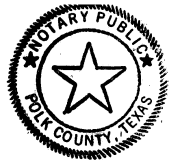
