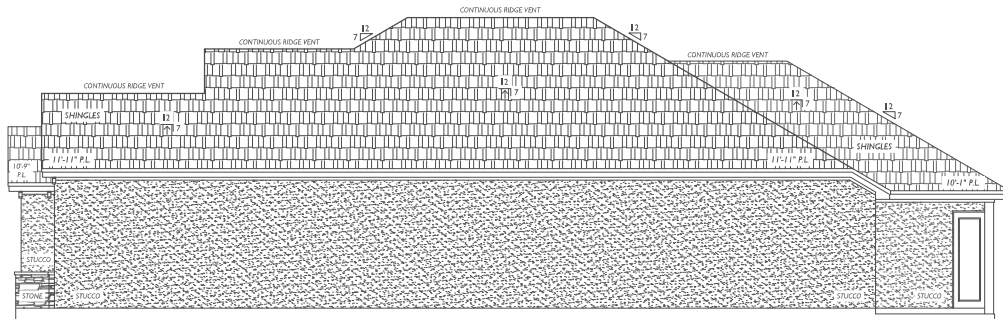

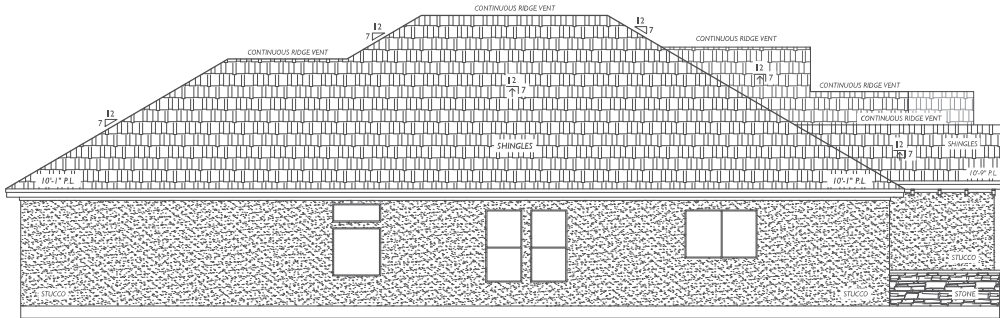
RIGHT ELEVATION

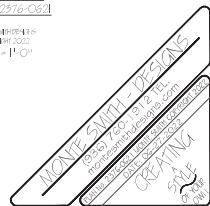

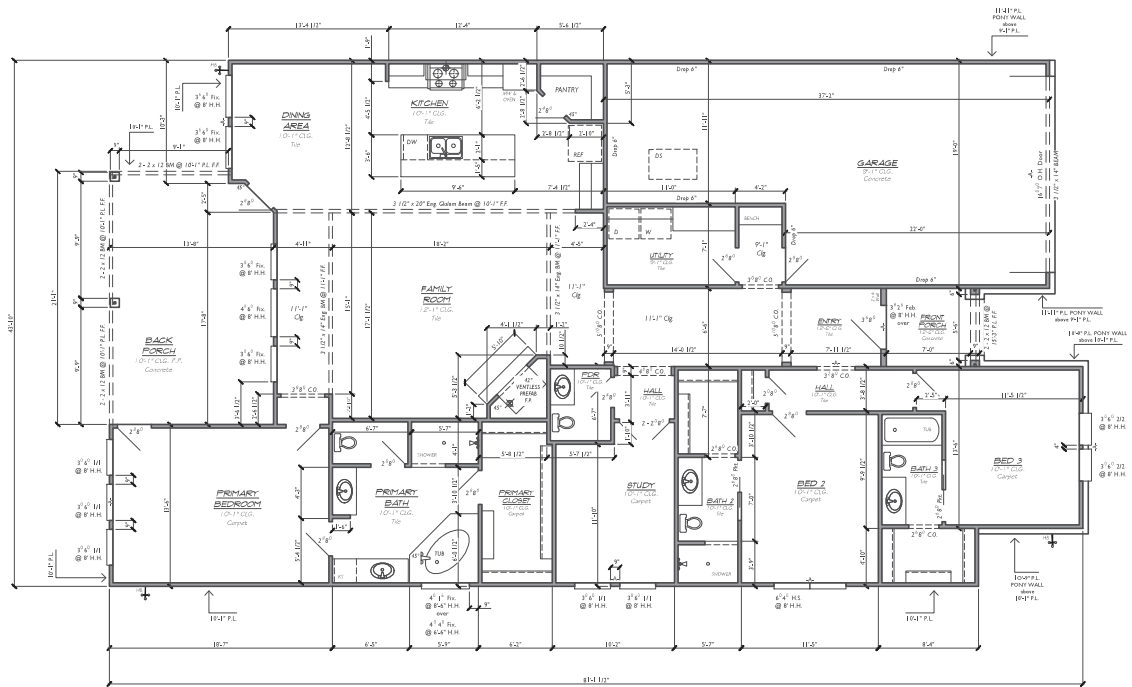

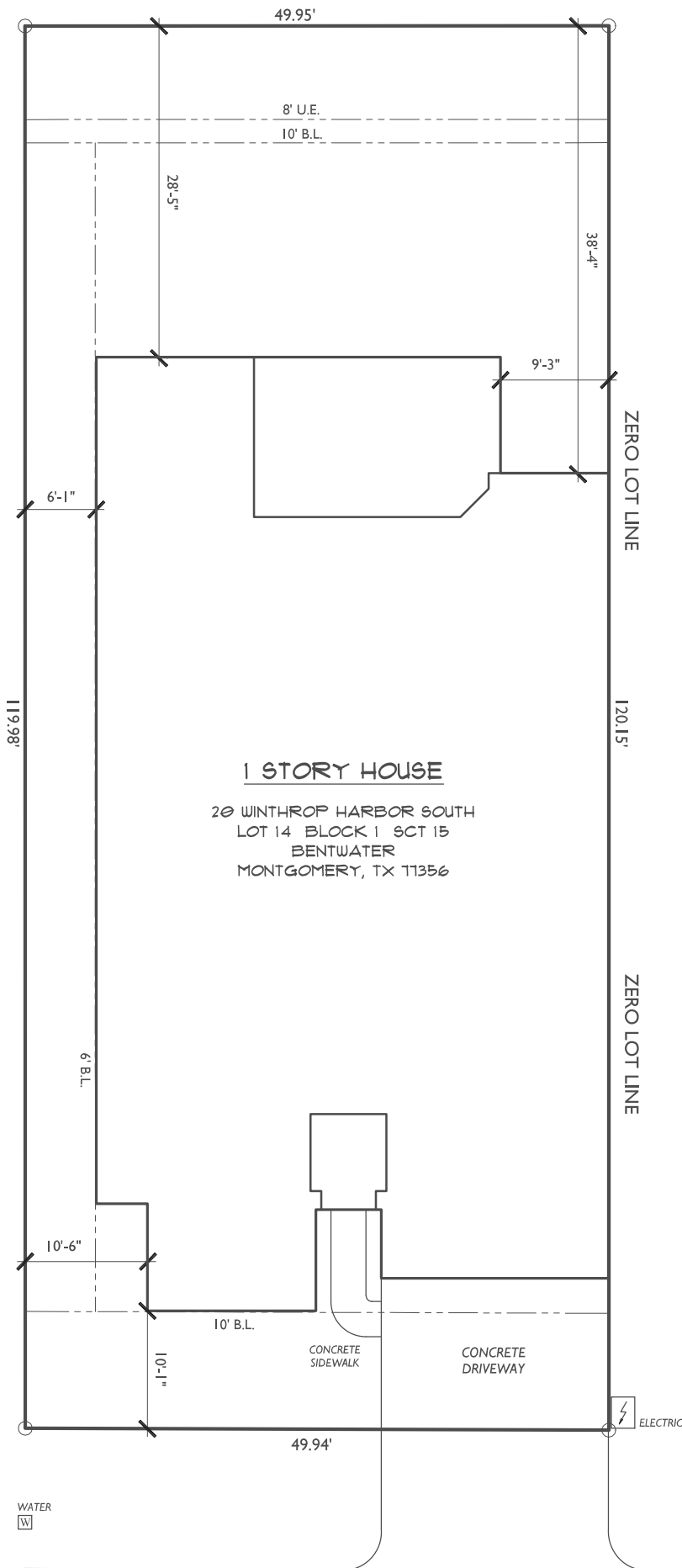
